## **Consent Policy**

#### Introduction

Where consent is required, we will ensure that we obtain consent in such a way that it is:

- freely given
- specific
- informed and
- unambiguous.

We will obtain consent by a positive opt-in and will not infer it from silence, pre-ticked boxes or inactivity.

We will put in place and communicate simple ways for people to withdraw consent should they wish to do so.

Where we, as a congregation, are supplied with a form of consent by a third party (for example, GB, BB, Taking Care or an event organiser) we will review it for GDPR compliance before using it. Where we are solely responsible for designing a form of consent, we will do so in a manner which is consistent with data protection guidelines.

#### Children

Under GDPR in the UK anyone under the age of 13 is considered a child for the purpose of obtaining consent for personal data processing.

Where consent is required for a child under 13 years of age, then this must be obtained from a person holding "parental responsibility".

For children aged 13 and above, consent may be given by the child.

In the Republic of Ireland, the relevant age is 16.

The Presbyterian Church in Ireland encourages parents or guardians to discuss with their children the importance of personal data and the intention of data protection legislation.

Bearing this in mind and taking into consideration the desirability of having consistency across PCI, we will design our consent forms where children are involved as follows:

- For children under the age of 13, consent must be obtained from a person holding "parental responsibility";
- For children over 13 but under the age of 16, there is the opportunity for sign-off by both parent/guardian and the child,
- For children aged 16 and over, sign-off is by the child.

## **Church Member Explicit Consent**

#### Information we collect and how we use it
